- DATE** Saturday March 17, 2012. **Warm-Up 7:30 AM Deck Entries** until 7:00AM **Meet starts: 8:30AM**
- FACILITY** Two (6) lane 25 yard pools with wave reduction lane lines. Daktronics Timing Systems. One pool (six lanes) will be used for competition, 2 lanes will be available for warm up/warm down during competition in the second pool.
- ELIGIBILITY** Open to all USMS-registered swimmers age 18 and older. **A legible copy of your current 2012 USMS registration card MUST be included with the meet entry form.**
- ENTRY** Fees \$30; swimmers are permitted to enter 5 events plus 1 relay. Deck entries \$35. **Enter YARD times for all events.**
- ENTRY DEADLINE** Entries must be received by March 7, 2012. Deck entries will be accepted at 7:00am the day of the event. Please make checks payable to CVSC and mail meet entries to **Masters Meet Director, 657 Chestnut Street, Bridgeville, PA 15017. - AWARDS** St. Patty's prizes will be awarded to the first through third place in all individual events. For purposes of awards and scoring, the age of the youngest relay team member shall determine the age group in the following age categories: 18+, 25+, 35+, 45+, 55+, 65+, 75+, 85+, etc. **No awards will be mailed after the meet had concluded.**
- SEEDING** Heats will be formed by submitted times, regardless of age or sex, and will progress from fast to slow to "NO TIME" and deck entries. Individual heat sheets will be distributed just prior to meet start time.
- DEADLINE** Entries must be received by (NOT POSTMARKED) March 7<sup>th</sup> 2012. All entries received after the deadline date will be consider deck entries. Fill in all contact information to enable us to reach you if there's a discrepancy.
